United Nations Educational, Science and Cultural Organization (UNESCO) hereby invites qualified companies to submit sealed tenders for consulting services to carry out the Evaluation of UNESCO's Strategic Programme Objective (SPO) 4: "Fostering policies and capacity-building in science, technology and innovation".

The core evaluation team will ideally comprise two international consultants and two IOS staff members. Depending on the evaluation approach developed by the core team, other national consultants, advisers and/or agencies with specific expertise in the natural science field may be hired to contribute to the evaluation process.

The two staff members of the Internal Oversight Service will provide methodological guidance and manage the evaluation process.

The external consultants should possess the following qualifications:

1. The team leader will possess at least 10 – 15 years of professional experience in programme and project evaluation of relevance to policy making, to include international experiences. He/she will also have a strong record in leading and/or conducting evaluations (required).
2. Advanced university degree in one of the basic sciences or engineering required, with additional qualification in public policy desirable.
3. Professional experience/expertise in capacity-building and/or policy in the basic sciences, engineering, energy and/or innovation (required).
4. Some knowledge of the United Nations, including previous work experience or assignments for the UN (preferred).
5. One team member will have experience in gender analysis or gender evaluation methodologies (preferred).
6. Excellent oral communication and report writing skills in English (required) and working knowledge of French would be an asset.
7. All team members will also have professional experience in programme and project evaluation (required).

Two samples of previous evaluation work, preferably relevant to the subject of this evaluation, must be submitted as part of the technical proposal.

Preference will be given to evaluation teams that are multicultural with appropriate gender balance and geographic representation.

The time schedule for the evaluation is planned between August and December 2009.

The purpose of this notice is to provide general information on the requirements for the procurement process and to inform interested suppliers how to obtain a copy of the Solicitation Documents.

Interested companies who wish to participate in the OIC must request for a complete set of Solicitation Documents, available free of charge, from UNESCO contact person at the address shown below.

The sealed tenders must be delivered to the UNESCO Headquarters in Paris no later than **31 July 2009, 17h00 (GMT+1)**, in strict compliance with the instructions as stipulated in the Solicitation Documents.

UNESCO reserves the right to amend the documents at any time during the solicitation process. Any amendments or clarifications will be communicated directly to all Bidders who have requested for a complete set of solicitation documents and officially confirmed their intention to submit a sealed tender. No remuneration will be made to companies for preparation and submission of their tenders.
